Paragraph No. 1 & 2 shall remain unchanged and the remaining text of the REOI shall be replaced with the following:

Interested firms/institutions/organizations with international experience are requested to submit their Expression of Interest (EOI) for the above services. The EOIs would be reviewed on the basis of the following:

- (a) Name(s) of firm(s) with corresponding address, facsimile numbers and e-mail with specific information on age of business of consultant (firm) and joint venture Partner(s).
- (b) Organizational chart showing the firm's/institution's structure including the positions of directors and key personnel. In case of joint venture, each institute/firm of the joint venture should present its organization chart.
- (c) Turnover of consultant (firm) in the last five (5) years.
- (d) List of similar types of contract signed in the last 10 (ten) years with brief contract description, location and contract value.
- (e) Summary of institute's/firm's other assignments in Bangladesh and internationally.

Firms may associate to enhance their qualifications, but only in the form of "joint venture" or of "sub-consultancy". In the case of joint venture, all members of such Joint Venture should have real and well-defined inputs to the assignment, and it is preferable to limit the total number of firms in the association up to four.

Special Instructions:

- a. Incomplete/ partial EOIs will be rejected.
- b. Interested firm (s) must provide focused information demonstrating that they are qualified to perform the services.
- c. The authority reserves the right to accept or reject any or all of the EOI, or annul the EOI process at any stage without assigning any reason(s) whatsoever and without incurring any liability to the affected applicant(s).

Firms will be selected in accordance with the procedures set out in the World Bank Guidelines: Selection and Employment of Consultants by the World Bank Borrowers, May 2004 (revised October, 2006).
